For newly established accounts, set up takes 14 business days to implement. The ACH (Automated Clearing House) will validate the banking information for AAUW to make deposits to your account. NOTE: FUNDS ARE NOT WITHDRAWN FROM YOUR ACCOUNT.

For existing accounts, changes to routing or account numbers will also require 14 business days to implement. Any dues due to you during this time will be sent by check until the ACH becomes is validated and available for use.

Changes to dues rates will require one business day to update in the MPP system.
