#### DUES

Audrey Chambers reviewed the proposed budget for the coming program year. It is attached to the email with this newsletter. The budget was approved.

We held a discussion about dues and an how members can renew or join our Branch. You can go directly to the national AAUW website to renew with credit card. This is the preferred method. It will take care of the national, state and local dues all at one time. Disbursement of funds will come back from national to our local Branch and AAUW WI.
